BACKGROUND

Section 284 of the Municipal Act 2001 requires that:

*284 (1) **Statement** - The treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,*

“(a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;”

Section 284 (4) of the Municipal Act 2001 states:

*284 (4) **Public Records** – Despite the Municipal Freedom of Information and Protection of Privacy Act, statements provided under subsections (1) and (3) are public records.”*

The City’s policy has been to post these reports on our website in accordance with Municipal Act 2001 Section 284(4).
